9:00 a.m. – Skippers Meeting (yachts should be ready to race before meeting)
10:00 a.m. – Racing Starts
12:00 p.m. – Lunch (provided to competitors)
1:00 p.m. – Racing resumes. We will attempt to complete 5 races for the day
No race shall start after 3:00 p.m., awards to follow last race

Eligibility:

For all 2009 TCYS regattas, a sailor's age is their age on June 19, 2009

C420 and Laser sailors must be less than age 21 on June 19, 2009.

Optimist sailors must be less than age 16 on June 19, 2009.

Optimist Green Fleet (ILYA No Tears): Must be a novice sailor age 15 or under.

Optimist White Fleet: Age 10 and under

Optimist Blue Fleet: Age 11 and 12

Optimist Red Fleet: Age 13 through 15

An adult advisor, parent, or coach must accompany participants under 18 years of age.

Fees:

Entry fee is \$25 per Optimist, \$25 per Laser (All classes) and \$40 per C420 team. No participant will be accepted without entry fee. The entry fee is not refundable. TCYS Membership Annual membership Fee \$25 will be collected at this event.

Trophies:

Participation Ribbons will be presented to all Optimist Green Fleet sailors. Awards will be presented to the top 3 finishers in the Optimist White, Blue and Red Fleets.

Risks:

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor, or in the case of minors, each competitor's parent or guardian agrees to release the race organizers from any and all liability associated with such

competitor's participation in this event to the fullest extent permitted by law.

Rules:

The regatta will be governed by the 2009-2012 ISAF Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association, the Optimist Class Rules, ILYA Rules, this Notice of Race, and the Sailing Instructions. Protests will be heard in all fleets, except the Optimist Green, with the PRO, or their designated representative hearing all protests.

Scoring:

The Low Point Scoring system will be used. If five (5) races are completed, there will be one discard, if four (4) or less are completed there will be no discards.

Courses:

Optimist White, Blue and Red Fleets will be sailed on the same course and start together, but scored separately. The Optimist Green Fleet will be sailed on a separate course. All Laser and C420 fleets will be sailed on the same course.

WAIVER OF LIABILITY: I recognize and understand that participation in the regatta is voluntary, and that my child incurs risks by participating, including the possibility of death or injury. In consideration of the acceptance of my child's entry, I waive any and all claims, charges, losses and liabilities including those caused by negligence, against the Inland Lake Yachting Association and its host clubs, their respective officers, trustees, contractors, employees, and members, and against any and all volunteers, which may arise from, or in any way be in connection with, the practices or activities of the regatta and its organizers. I am aware that the activities of my child may involve maneuvering a boat on deep waters in potentially hazardous conditions which may include among other things, cold water temperature, strong winds and high waves, sudden and unexpected immersion in deep waters and collision with other watercraft or stationary objects such as docks, pilings, and buoys. I understand that I am responsible for the actions of my child while he or she may be participating in the regatta and on the grounds of the event host, and that I am solely responsible for deciding whether or not my child participates or continues participating in the event. We also agree that the sailor will be bound by the Racing Rules of Sailing, the rules of ILYA and by all other rules that govern this event.
